Service Carries on Through Firestorms

The California wildfire season got off to an ominously early start in June when the Angora fire in the South Lake Tahoe area destroyed numerous homes. Fortunately, that was the only fire to strike the northern part of the state so far this year. The south state, however, was not nearly so fortunate.

Southern California can be particularly susceptible to wildfires because of unique geographical circumstances that exist there. A high pressure system sometimes will form over the Great Basin area of Nevada and Utah while a low pressure system will form off the southern California coast. The winds move from Northeast to Southwest to fill the resulting vacuum. They pick up velocity and heat by compression as they move through the canyons of the mountain ranges that separate the interior desert areas from the coastal plains and valleys. These are the infamous Santa Ana winds that blow most commonly in the fall and early winter months. The hot, dry winds began blowing with a particular vengeance in mid October through an area that had seen record low rainfall during the preceding 18 months. With temperatures soaring to over 100 degrees, conditions were ripe for catastrophic wildfires.

The first fire broke out on about October 19 in the hills above the wealthy seaside enclave of Malibu. Another began a day later in the mountains that surround northern Los Angeles County's Santa Clarita Valley. In comparison to what was to come, these fires did relatively little damage. The really big fires broke out in San Diego County beginning on October 20. At one point, these fires surrounded San Diego on three sides and there was concern they would burn all the way to the ocean. Then, on October 22, fires broke out in the San Bernardino Mountains that rise sharply above the rapidly urbanizing plain east of Los Angeles known as the Inland Empire.

The impact of these fires was enormous. Although exact numbers are hard to come by, it is estimated that nearly 750,000 people were evacuated throughout southern California. In San Diego County alone, nearly half a million people were forced to abandon their homes. Altogether, 480,000 acres were burned and 1,575 homes were lost. The fires claimed 10 victims. These fires came on the heels of the fires that burned through the area in 2003. In San Diego County, those fires consumed over 2,400 homes and left 18 dead.

Five of the judges from our San Diego office were forced to evacuate their homes. These included NAUIAB Second Vice-President Cynthia Thornton. Cynthia and her family were forced out on Sunday, the 21st. Cynthia sent an email to the Board of Governors in which she described the fire in part as follows. "The Witch Creek fire is about three miles away from my home, but the winds have died down and it looks like we may be able to go home tonight (Wednesday, October 24). They lit back fires and now it looks like there are only a few hot spots near us. The inside of our house smells like smoke even though we changed the air conditioning filters and kept the house closed since Sunday. We have a huge clean up job ahead of us!.....The fire itself is impressive. My husband and I drive to a ridge about a mile north of our house to keep an eye on it. There you can see a fire line over a mile long. When it hits a house or trees, they go up like a torch. A lot of people are wearing face masks but that only keeps out the smoke particulates. A lot of other stuff is burning and the chemicals go straight through the mask and do the most damage."

The Witch Creek fire that Cynthia describes was the largest of the fires. It consumed 1,061 homes. Also evacuated was the Presiding ALJ, Harold Rucker. He was not able to return to his home until Friday evening.

Two judges were evacuated from our Inland Empire office including Kirk Garvin, the Presiding ALJ. They live at the 6700 foot level in the San Bernardino Mountains. They were not able to return home until October 31.

The impact on our operations was surprisingly light. Staff affected by the fires were given administrative time off. In the Inland Office, staff took 43 hours off while judges took 7.5 hours off. No calendars were cancelled in Inland and only 14 cases had to be reset because of the fires. Non appearances for the week of October 22 totaled 91. In San Diego, the staff took 46 hours of administrative leave while judges took 80 hours. Even most of the judges who had been evacuated, including Cynthia, reported to work and heard their cases. San Diego was forced to cancel one and half calendars and to reset 87 cases. Non appearances totaled 155 out of approximately 350 hearings that were set for that week.

It was notable that the office remained open during the week of the fires, particularly in view of the fact that the courts and all San Diego city and county offices and the schools were closed. As Cynthia described, there was a great deal of soot

Notes and Information from the July 2007 NASWA UI Committee Meeting

Some of the highlights from Dale Zeigler, USDOL, include:

- WIRED (Workforce Initiative in Regional Economic Development) is still a big issue at ETA. They are looking at Claimants as a "talent pool"; trying to get UI to be a bigger part of the planning; and looking at getting good and useful data on who the unemployed are, using Auto-Coder. There was also discussion as to how profiling or REAs (Re-Employment Assessment) fits into this concept.
- In April 08 there will be an Integrity Conference in Salt Lake City, UT.
 DOL has established an Initiative on Improper Payments OVs are
 increasing for unknown reasons.
- The SIDES (Separation Information Data Exchange System) project is much closer to being ready for testing. They anticipate that this could create substantial savings in postage, printing, etc.
- 4. Concern was expressed that there is an apparent "disconnect" between UI and ETA. It was reported that ETA testified before Congress, stating that states receive sufficient funding to run their UI programs. States were encouraged to try to plug these gaps by opening communication. This may be more significant for Appeals.

NASWA President Ted Halley (SC) spoke on several topics. Among them were the selection of Direct Employers to take over for America's Job Bank as of July 1, 2007, and the creation of a national UI award. A committee is continuing to work on the criteria for that.

John Sharkey, from ITSC, reported on several projects which they will be working on over the coming year. Those decisions were made based upon a survey conducted among the states.

Many states reported staff reductions and other cost-saving measures. Several had received Reed Act money and many are using that for technology improvements. Some states reported very healthy trust funds; some have trust funds nearing insolvency. Almost all states have begun using debit cards and/or direct deposit in lieu of paper checks.

and smoke in the air and traffic was at times gridlocked. The judges and staff were commended for their selfless efforts under very difficult circumstances.


Of course, many people was a start away from their jobs by the fires or had their places of employment destroyed. The State Workforce Agency has informed us they will be enforcing eligibility requirements, the fires not withstanding. Thus, we expect to see an increase in availability related cases. Then, of course, there are the disaster unemployment assistance claims. The agency is projecting 5,275 DUA claims which, they estimate, would generate approximately 550 appeals. These numbers seem low to us. Nonetheless, we are gearing up to meet the workload that was increasing before the fires. Meanwhile, we await the winter rains and the end of another fire season.

Comparisons have been made between Hurricane Katrina and the wildfires, but I believe the comparisons are inapposite. Hurricanes, like earthquakes, can strike at the heart of population centers while wildfires usually strike at the periphery, and they destroy infrastructure in a way fires do not. For those affected by these disasters, however, they are equally tragic.

One Last Thing

At our recent conference in Baltimore, I neglected to mention one thing. At the last Board of Governor's meeting, we agreed to present a lifetime membership to our esteemed colleague and Past-President, Robert Lorenzo. As you probably know, Bob retired after more than 30 years with the State of New York. He devoted many years of dedicated service to NAUIAB, and will continue to do so.
