

A Brief Overview of How UI and Domestic Violence Intersect

A woman is fired because her ex-boyfriend repeatedly shows up at her place of employment, hangs out in the lobby, and causes problems for security. A woman takes off in the middle of the night, after escaping an assault from her boyfriend, and moves three hours away without giving any notice or reason to her employer. A woman is fired for no-call no-shows after her boyfriend breaks her cell phone and she locks herself in the bathroom to escape his physical abuse. A man is discharged for absences after he is ordered to have emergency custody of his children because his ex-wife was threatening to harm the children.

All of these cases involve domestic or family violence. All of the claimants were unemployed through no fault of their own. Yet, until just recently, the claimants would not be eligible for unemployment insurance benefits, in most circumstances, because their separation would be determined to be a voluntary quit for personal reasons or a discharge for attendance, a breach of duty, or an employer's rule violation.

According to the Department of Labor, the purpose of unemployment insurance is to provide unemployment insurance benefits to persons who are unemployed through no fault of their own as determined under state law. In 2009, the American Recovery & Reinvestment Act was made law. This act granted states additional federal revenue if unemployment insurance eligibility was extended to persons who separated for "compelling family reasons," including domestic violence. American Recovery & Reinvestment Act, Pub. L No. 111-5 (Division B, Title II, Sec. 2003).

Victims of domestic violence may be unemployed as a result of addressing the multitude of issues that occur because of the domestic violence. This may include housing, childcare, needing to seek medical care, court appearances for both civil and/or criminal proceedings, transportation, and needing to seek counseling for themselves or children.



Since 2009, thirty-three states have carved out exceptions to victims of domestic violence. "State Law Guide: Unemployment Insurance Benefits for Victims of Domestic & Sexual Violence." Legal momentum: The

Women's Legal Defense & Education Fund. July 2014. Web. March 27, 2015. Depending upon the state, a claimant may need to provide a police report, protective order, medical records, or a statement substantiated domestic violence from a counselor, shelter worker, clergy member, attorney, or health worker. Id. In most states, employers' accounts are not charged if a claimant receives unemployment insurance benefits under this exception. Id. There are some states that require the claimant to give notice

to the employer that the separation occurred due to domestic violence. Id. In most states, domestic violence may include family or household members, which greatly expands the circle of persons that may need to be addressed. This would include any familial relationship, a legal relationship such as a foster parent or guardian, and persons who create their own household through their actions.


Domestic and family violence affects all members of society. It occurs to people of all ages, race, gender, sexual orientation, and socioeconomic levels. Domestic and family violence affects victims in the workplace through attendance issues, discrimination/harassment, and ultimately job loss. Domestic violence has a negative affect upon business



also. It causes an estimated loss of productivity of \$727.8 million per year according to the Centers for Disease Control. Jacobs, Lisalyn R. "Domestic & Sexual Violence in the Workplace." Legal momentum: The Women's Legal Defense & Education Fund. 13 February 2014. Web. March 27, 2015. Domestic violence also raises safety concerns for employers.

Last year, domestic violence took a front and center role in the media spotlight as the NFL dealt with the very publicized and shocking video of Ray Rice and his then fiancé involved in a domestic violence incident inside an elevator. This was followed with the criminal charges filed against Adrian Peterson stemming from injuries to his son after disciplining him with a tree branch or "switch". There were numerous media comments regarding the NFL's reaction to both incidents and whether or not the NFL's reaction was appropriate. While the NFL is not the typical employer in unemployment insurance appeals hearing, these incidents show the difficulties that employers face when addressing domestic and family violence.

I have conducted domestic violence hearings since 2010. My state requires claimants to provide documentation to substantiate the domestic or family violence. It is my experience that many claimants testify to domestic and family violence but are unable to substantiate it because they have not contacted law enforcement; they have not sought a protective order; and they have not sought counseling from a domestic violence service provider. It is difficult to hear testimony on these issues. However, I conduct these hearings to fulfill the underlying purpose of unemployment insurance – to provide benefits to persons who are unemployed through no fault of their own.



Cave and Cosmos: Shamanic Encounters with Another Reality by Michael Harner. The author was a professor of anthropology at UC Berkeley and writes about the similarities and differences of Shamanism between cultures all over the planet. The work is fascinating for the similarities between practices in Siberia and South America.

Proof of Heaven: A Neurosurgeon's Journey into the Afterlife by Eban Alexander III M.D. While I was not crazy about the title (the book proves nothing except Dr. Alexander's personal experience), I nonetheless loved this very quick read which is the fascinating story of the near death experience of the author who as a neurosurgeon is able to correlate what he experienced with his brain scans at the same time. I found the story particularly fascinating when compared with the experiences of some of the shamans described in Cave and Cosmos (above).

The Shoemaker's Wife by Adriana Trigiani. This book reputedly took over twenty years to write and is based on a family story. It is a multigenerational love story that takes place in Europe and

the U.S., spans two World Wars, and centers around the quest of two star-crossed lovers to find each other again. This is a well written romantic book. The pages flew by.

Reconstructing Amelia: A Novel by Kimberly McCreight. Based on the first few pages (which included text messages), I was sure I would hate this novel. I was wrong. It is a solid mystery and deals well with the emotional upheaval created by the tragedy at the book's beginning. It is a first novel by the author and includes some first novel failings (a little melodrama), but is well written, engaging and fun to read.

Americanah by Chimamanda Ngozi Adiche. This is one of the better discussions of race I've read. It's a novel where the main character, Ifemelu, is a Nigerian immigrant to the United States. Once here, she has keen observations of the complex racial relations in the United States from the perspective of a "Non-American Black." Adiche is a sharp observer of culture and her insights were both thoughtful and original. I'm a sucker for well written books and this author definitely knows how to turn a phrase. My big criticism of this book is the ending – no spoilers in these reviews so contact me for details!

Beautiful Ruins by Jess Walter. This is a sweet novel taking place in both Italy and the United States from the fifties to the present and is populated by artists. It is romantic in the sense that it presents a wide panorama of life and the characters are philosophical about their small place in that great world. The character development is intricate, full and whimsical. If you have even a small romantic bone in your body, this is the sort of book that puts words in an order you will want to memorize. The descriptions of the Italian coast alone are worth the price of admission. This story tells what happens to people after the story ends.

Greetings from the US Department of Labor's Office of Unemployment Insurance (UI) in Washington, DC! My name is Corey Pitts and I have the privilege of overseeing the UI Appeals program for the nation. I am very excited about renewing the Department's long-standing partnership with the National Association of Unemployment Insurance Appellate Professionals (NAUIAP) and look forward to working with states and organizations, such as NAUIAP to improve, innovate and preserve the UI program for future generations.

The first national peer review was held in the summer of 1997. For this review, states were asked to submit a subsample of cases from two quarters (quarters ending September 30, 1996 and December 31, 1996). The majority, if not all of the hearings were stored on tapes and all scoring was paper based. Subsequent national reviews followed this model until 2011 when states were required to submit a subsample of cases from the quarter ending the calendar year. Since 2011, each review has been slightly reinforced to accommodate the various technological advances that states have made along the way, including electronic scoring. Nowadays, most hearings are recorded and stored using recording software and several states image their documents and store them in data warehouses. What's in store for the future of Appeals? Well, the Department along with several states has been in the process of updating ET Handbook 382, as well as reengineering the format of the national review in consideration of diminishing institutional knowledge and financial resources. I look forward to sharing future announcements about several exciting products and activities associated with the Appeals reengineering.

My motto is much like that of Charlie Batch's and that is, "Proper Preparation Prevents Poor Performance." I believe that if we, as a team, strive to properly prepare our appellate professionals by continuously educating, sharing best practicing and assuring due process in all aspects of the appellate reviews, we can prevent or lessen the chances of poor performance. We all share a passion for the UI program overall and its mission to have a meaningful impact on the unemployed and the economy. As always, I seek opportunities for endeavors that will render improvements to the UI appellate process, and ultimately afford all appellate professionals continuous growth and development.

ANNUAL APPEALS REVIEW ANEW

The Department's responsibility for the oversight of the quality of states' UI appellate processes is grounded in the Social Security Act. Each year the Department hosts a national peer review, known as the Annual Appeals Review (AAR), to review subsample cases that states have already evaluated. Each case is evaluated against the thirty-one criteria contained in ET Handbook 382, Handbook for Measuring Unemployment Insurance Lower Authority Appeals Quality, and the quality of each state's Notice of Hearing and information about further appeal rights is assessed. Since the AARs inception in the mid-1990s, changes have occurred to enhance the process and more changes are underway.



On Tuesday night we have found a monument by moonlight trolley tour for those who register by May 20th. You may pay for tickets online when you register for the conference if you want to tour with our group or you can simply find a tour online (there are several) and register on your own.

Our tour will begin at Union Station. Transportation to get there will be on your own. The Moonlight Monument Tour is a 2.5 to 3 hours tour on an old-fashioned trolley with expert narration as you admire illuminated monuments and memorials, the Capitol Building, the White House and Georgetown. The tour stops at the FDR Memorial, the Lincoln Memorial, the Vietnam Memorial, the Korean War Memorial, and the Iwo Jima Memorial. Join the professional tour guides for entertaining anecdotes and historical information along with a sprinkling of ghost stories about the spirits who haunt the Nation's capital.

If you are not interested in a night time tour or are looking for something shorter, several companies offer hop on hop off tickets

for all day bus tours which can also be purchased on-line or when you arrive. These sound like a great way to have transportation and a city tour at the same time.

For general transportation information, click here. Transportation is also available on the Metro and the DC Circulator, which covers much of the city and costs only \$1.

On Wednesday Night we are offering a great opportunity to see a live show at the Kennedy Center. Some of our members have previously attended the show and recommend it highly. According to the show's web page, the comedy-whodunit takes place in the "Shear Madness" hairstyling salon and is chock full of up-to-the-minute spontaneous humour. It sounds like it will provide our group of judges the perfect opportunity to exercise our skills at asking questions and weighing facts, but all in fun. The original script was written to use as a study of how people perceive or misperceive reality. The brief play was set in a uni-sex hair salon and revolved around the off-stage murder of a concert pianist. Subjects were asked to solve the murder based on their individual perceptions of the events and the six stereotypical characters surrounding the murder. In the current show, a murder is committed and the audience gets to spot the clues, question the suspects, and solve this funny mystery. The outcome is never the same, so even if you have seen it before each performance is essentially a new show.

"Shear Madness" has received the Raven Award from the Mystery Writers of America and has been inducted into the Comedy Hall of Fame, the first play ever to receive that accolade. "Shear Madness" is listed in the Guinness Book of World Records as the longest running play in the history of the USA. The web page states: "Over 11 million people worldwide have joined in the fun, and while no one has actually died laughing, some are still rolling in the aisles."

On Thursday night there are at least two options. For the sports fans, the Washington Nationals will be in town on Wednesday and Thursday nights for 7 pm games. Tickets are available online, but watch the NAUIAP web page for more information. Additionally, some may want another opportunity to relax with a moonlight tour. One of the recommended highlights is a moonlight cruise on the Potomac to view the monuments. This is a 45 minute cruise leaving from the Washington Harbor on K street in Georgetown. You can book your cruise directly at http://capitolrivercruises.com/tours.html. There are also a number of dinner cruise offerings you can find at Washington.org or online under Washington DC river cruises.
